'That, Mr David Paul Robinson, who was appointed as a Non-executive Director of the Company on 27 May 2015 and in accordance with clause 19.3(b) of the Company's Constitution, and being eligible, be re-elected as a Director of the Company'.

NOTES

- (a) Subject to the *Corporations Act*, including sections 250R and 250BD, a member who is entitled to attend and cast a vote at the meeting is entitled to appoint a proxy.
- (b) The proxy need not be a member of the Company. A member who is entitled to cast 2 or more votes may appoint 2 proxies and may specify the proportion or number of votes each proxy is appointed to exercise. If no proportion or number is specified, each proxy may exercise half of the member's votes.
- (c) If you wish to appoint a proxy and are entitled to do so, then complete and return the enclosed proxy form. To be effective the proxy form must be received at the share registry of the Company, Computershare Investor Services, no later than **3.00pm (Brisbane time) on Sunday, 20 May 2018**. - (d) If voting by attorney, a proxy form and the original power of attorney (if any) under which the proxy form is signed (or a certified copy of that power of attorney or other authority) must be received by Computershare Investor Services no later than **3.00pm (Brisbane time) on Sunday, 20 May 2018**.
- (e) A corporation may elect to appoint a corporate representative in accordance with section 250D of the *Corporations Act* in which case the Company will require written proof of the representative's appointment which must be lodged with or presented to the Computershare Investor Services before the meeting.
- (f) The Company has determined in accordance with Regulation 7.11.37 of the Corporations Regulations 2001 that for the purpose of voting at the meeting, shares will be taken to be held by those persons recorded in the Company's register of members as at **7.00pm (Brisbane time) on Sunday, 20 May 2018**.
- (g) If more than one joint holder of Shares tenders a vote at the AGM (whether personally, by proxy, by attorney or by representative), only the vote of the joint holder whose name appears first on the register will be counted.

VOTING EXCLUSION STATEMENT

Item 2

The Company will disregard any votes cast in favour of Item 2 by or on behalf of a member of the Key Management Personnel whose remuneration is disclosed in the Remuneration Report or any of their closely related parties (regardless of the capacity in which the vote is cast), unless:

- (a) **directed proxy** the person does so as a proxy appointed under and in accordance with the directions on the proxy voting form; or
- (b) undirected proxy to Chair the person is the Chair of the meeting and does so as a proxy appointed under the proxy voting form (or appointed by default), where the proxy voting form does not direct the proxy how to vote on Item 2 and expressly authorises the Chair of the meeting to exercise the undirected proxy even if Item 2 is connected directly or indirectly with the remuneration of a member of the Key Management Personnel (which includes the Chair of the meeting), and the vote is not cast on behalf of a member of Key Management Personnel or a closely related party of such a member.

The Chair of the meeting intends to vote undirected proxies in favour of Item 2.

Further details regarding proxy voting are set out in the proxy form accompanying this Notice of Meeting.

EXPLANATORY NOTES

The Explanatory Notes have been prepared to assist Shareholders with their consideration of the items to be put to the Annual General Meeting to be held on **Tuesday, 22 May 2018**.

1. Annual Financial Report and Directors' and Auditor's Reports

The *Corporations Act* requires that the report of the Directors, the Auditor's report and the Financial Report be laid before the AGM. In addition, the Company's Constitution provides for such reports and statements to be received and considered at the meeting. Apart from the matters involving remuneration which are required to be voted upon, neither the *Corporations Act* nor the Constitution requires a vote of Shareholders at the AGM on such reports or statements. Shareholders will be given ample opportunity to raise questions with respect to these reports and statements at the meeting.

In addition to being given a reasonable opportunity to ask questions at the meeting, Shareholders may address written questions to the Chair about the operations and management of the Company, or to the Company's Auditor, which are relevant to:

- (a) the independence of the Auditor in relation to the conduct of the audit;
- (b) the preparation and content of the Auditor's Report to be considered at the meeting; or
- (c) the conduct of the audit of the Financial Report to be considered at the meeting.

EXPLANATORY NOTES (CONTINUED)

2. Item 2 — Remuneration Report

The Corporations Act requires that Shareholders be asked to vote on the Remuneration Report.

This report can be found on pages 14–19 of the Annual Report which is available on the Company's website at www.devinegroup.com.au. It sets out the remuneration policy of the Company and reports on the remuneration arrangements in place for KMP during the 2017 Financial Year.

Note that under section 250R(3) of the *Corporations Act*, the vote by Shareholders is **advisory only** and is **not binding on the Directors or the Company**. However, if more than 25% of the votes cast on this item are against the adoption of the Remuneration Report, the Remuneration Report for the following year must either address any comments received from Shareholders or explain why no action has been taken in response to those comments.

A reasonable opportunity will be provided for discussion of the Remuneration Report at the AGM. The Board unanimously recommends that shareholder vote in favour of Item 2. The Chair of the meeting intends to vote undirected proxies in favour of all proposed resolutions, including Item 2.

3. Item 3 — Re-election of Director – Mr David Paul Robinson

Mr Robinson has held the position of Director of the Company since 27 May 2015 and Chairman since 19 January 2016.

Under rule 19.3(b) of the Constitution, a Director (who is not a managing director) may not hold office without re-election beyond the third AGM following the meeting at which the director was last elected or re-elected.

In accordance with rule 19.3(b) of the Constitution, Mr Robinson will retire at the AGM and is standing for re-election as a Non-executive Director.

Mr Robinson's election as a Non-executive Director has been proposed by the Company's major shareholder, ASX-listed CIMIC Group Limited.

Mr Robinson has been a Non-executive Director of CIMIC Group Limited since December 1990. He is a chartered accountant and partner of ESV Accounting and Business Advisors, which advises local and overseas companies with interests in Australia. Mr Robinson participates in construction industry affairs. He is also a director of Catholic Schools NSW Limited and formerly a Trustee of Mary Aikenhead Ministries, the responsible entity for the health, aged care and education works of the Sisters of Charity in Australia. Mr Robinson was a Director of Leighton Properties Pty Ltd from 2000 to 2012.

If Mr Robinson is not re-elected as a Director at the AGM, then the prescribed minimum number of Directors under the *Corporations Act* and the Constitution will not be met.

Directors' Recommendation

The Board (excluding Mr Robinson) unanimously recommend that you vote in favour of Item 3.
