Key milestone achieved towards the launch of a video solution in FY19

Audinate Group Limited (ASX: AD8), developer of the professional AV-industry leading Dante® audio over IP networking solution, is pleased to announce the preview of a video prototype at the upcoming InfoComm tradeshow in Las Vegas on 6th – 8th June 2018.

The video prototype utilises Dante® networking and JPEG 2000 video compression technology to manage and distribute high quality digital video signals across existing computer networks. Standard HDMI video signals are converted to and from streams of packets that can be transmitted through typical in-building network infrastructure. This enables users to manage the distribution of both audio and video signals with Dante Controller, and ultimately the entire Audinate technology stack. The prototype will be demonstrated to prospective OEM customers by invitation only at InfoComm.

InfoComm is the largest pro-AV tradeshow in North America with over 1,000 exhibitors and 44,000 attendees. It will include more than 100 Audinate customers (OEMs) showcasing Dante® enabled products and services.

The Dante® video prototype is a key milestone towards the release of a commercially available video solution during the year ending 30 June 2019 (FY19). Based on the current timelines this new video-based product set will commence contributing to revenues in FY20.

Audinate will also demonstrate its Dante Controller software managing audio and video signal distribution between Software Defined Video over Ethernet (SDVoE) devices at the SDVoE booth at InfoComm 2018. The SDVoE Alliance is a consortium of technology providers collaborating to standardise the adoption of ethernet to transport video signals in professional AV environments. The SDVoE alliance founding members are Aquantia, Christie Digital, NETGEAR, Semtech, Sony and ZeeVee. Audinate has joined the SDVoE Alliance as a contributing member.

Mr. Lee Ellison, CEO of Audinate said: “We have long heard from our customers that they want an integrated, interoperable way to control their video over IP alongside their Dante audio. These demonstrations at InfoComm are the first step toward making this desired experience a reality.”
