**ASX Announcement**

**50MW KIDSTON SOLAR PROJECT REVENUE UPDATE**

Genex Power Limited (**ASX: GNX**) (**Genex** or **Company**) is pleased to report unaudited generation in relation to the operation of the 50MW Kidston Solar Project (**KS1** or **Project**) in North Queensland. KS1 has continued to generate consistently into the National Electricity Market (**NEM**) during commissioning.

A summary of the revenues earned to date can be found in Table 1.

1. Unaudited financial information;
2. Revenue comprised of energy and LGC sales on accrual basis;
3. Queensland Government Revenue Support Deed to commence on practical completion;
4. Previous revenue reported for April adjusted due to revised realised energy and LGC settlement prices;
5. LGC revenue will revert to Govt. upon practical completion anticipated July 2018;
6. All revenue during commissioning phase is derived from selling into the spot market; and
7. May 2018 revenue includes unrealised LGC revenue.

Generation in May has been slightly below expectations due to higher than usual wet weather occurrences for this time of year.

The Project remains on budget and is now in the final testing and commissioning stage. Current maximum generation is now 45MW with practical completion anticipated during July 2018.

ARENA:

The Federal Government, through the Australian Renewable Energy Agency (**ARENA**), has provided \$8.9 million in funding to support the construction of Genex's KS1 Project, and up to \$9 million in funding to support the development of K2-Solar and K2-Hydro.

Queensland State Government:

The Queensland State Government has continued to support the development of the Kidston Renewable Energy Hub, providing a 20-year revenue support deed for KS1 through the Solar 150 Program, and designating the Hub as '*Critical Infrastructure*' to the State.
