Notification under section 708A(5)(e) of the Corporations Act 2001 (Cth)

Bigtincan Holdings Limited (**BTH**) has today issued an Appendix 3B with respect to the placement of 42,857,143 ordinary shares announced on 18 June 2018 (**Placement**). Details of the Placement are set out in the announcement of 18 June 2018 and in today's Appendix 3B.

BTH gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**the Act**) that:

1. under the Placement, BTH has issued 42,857,143 ordinary shares at the issue price of \$0.35 per share, raising approximately \$15 million without disclosure to investors under Part 6D.2 of the Act; and
2. as at the date of this notice:
 - (a) BTH has complied with the provisions of Chapter 2M of the Act as they apply to BTH;
 - (b) BTH has complied with section 674 of the Act; and
 - (c) there is no "excluded information" within the meaning of sections 708A(7) and 708A(8) of the Act which is required to be disclosed under section 708A(6)(e) of the Act.
