Jack-In Group wins Persiaran Hartamas project in Malaysia

Piling and foundation services specialist Jack-In Group Limited (ASX: JIP) has secured the sub-contract package works for a commercial development project in the Federal Territory of Kuala Lumpur, Malaysia at a contract value of MYR5,243,192.38 (A\$1,744,938.89⁽¹⁾).

JIP, via its wholly-owned subsidiary Jack-In Pile (M) Sdn Bhd has accepted the Letter of Award (also known as Job Order) as Sub-Contractor to design, supply and complete the piling, pile cap and earthworks for the development of a 23 storeys commercial building comprising of serviced apartments, elevated and basement carparks and commercial units.

Salient terms of the Letter of Award are as follows:

Contract sum : MYR5,243,192.38

Contract term : Specific works agreement to be completed by 2nd September 2018

Main Contractor/ Client : Ireka Engineering & Construction Sdn Bhd

Payment terms : Monthly progressive payment concluded on percentage of completion

Defects liability period : 24 months from date of Certificate of Practical Completion

Binding contract : There are no additional conditions that need to be satisfied before the Contract

becomes binding. The Letter of Award together with JIP's tender documents shall

constitute a binding contract between JIP and the Main Contractor.

Termination Clause : The contract may be terminated by the Main Contractor if the Sub-Contractor

becomes insolvent or without reasonable cause fails to commence work, suspends his work, refuses to comply with instructions or abandons work. The contract may also be terminated if the contract of the Main Contractor with the Employer is

determined.

The project above is expected to generate a revenue of MYR5,243,192.38 (A\$1,744,938.89⁽¹⁾) and a gross profit of approximately MYR524,000.00 (A\$174,387.64⁽¹⁾) towards JIP for the financial year ending 31 March 2019.
