TRADING UPDATE 2Q18

Silver Heritage Group Limited ("Group" or "The Company") is pleased to provide the following Trading Update for the 2nd quarter to 30 June 2018 ("2Q18").

2Q18 Trading Update¹

- 2Q18 Group Gross Gaming Revenue ("GGR") up +39% on 1Q18 to US\$11.39m
- 2Q18 Group Net Gaming Revenue ("NGR") up +36% on 1Q18 to US\$5.88m
- 2Q18 Group Total Sales Revenue up +38% on 1Q18 to US\$6.60m
- Cash Balance at 30 June 2018 was US\$6.57m

Phoenix International Club, Bac Ninh, Vietnam

2Q18 GGR was US\$8.52m: up +33% on 1Q18, and up +44% on 2Q17

The Millionaire's Club and Casino, Kathmandu, Nepal

2Q18 GGR was US\$1.52m: up +80% on 1Q18, and up +38% on 2Q17

Tiger Palace Resort Bhairahawa, Nepal - Trading Update

The key KPI's of Resort (Non-Gaming) and Casino (Gaming) Revenues, visitation (footfall), and occupancy have all grown steadily since casino license issued 28 December 2017.

- Total Revenue was up +73% in 2Q18 on 1Q18
- Total Drop (cash exchanged for chips) in 2Q18 was up +33% on 1Q18 to US\$4.75m
- Gross Gaming Revenue was up +50% on 1Q18 to US\$1.35m in 2Q18
- Non-Gaming Revenue was up +145% on 1Q18 to U\$\$548,000 in 2Q18
- In the 6 months to June 30 the casino has registered over 17,300 patrons
- Strong recurring visitors with total footfall of 45,100 since casino license issued
- Hotel Occupancy over 79% in month of June 2018
