On 19 June 2018, Paradigm Biopharmaceuticals Limited ACN 169 346 963 (**Company**) announced that it issued 2,285,716 fully paid ordinary shares in the Company by exercising 2,071,430 options at an exercise price of \$0.375 per option expiring 07 August 2018 and 214,286 options at an exercise price of \$0.50 per option expiring 07 August 2018.
