Geophysical Surveys contracted for RLC's Lithium Projects

Reedy Lagoon Corporation Limited (ASX:RLC) has engaged International Imaging Inc. to carry out 3-dimensional Audio Magneto Telluric (3D AMT) surveys at RLC's Alkali Lake North Project and its recently staked Clayton Valley Project.

These geophysical surveys are expected to be completed in July with results interpreted and reported by end August.

RLC is seeking lithium brines. It will use the 3D AMT surveys to identify conductivity anomalies, indicative of brines.

Following a review of the 2 dimensional AMT (2D AMT) geophysical surveys carried out on the Company's properties (ASX releases dated 26,29 & 30/05/2018) and results of drilling and pump testing on Columbus Salt Marsh and Big Smoky South (ASX releases dated 23/04/2018, 14/05/2018), it was decided that 3D AMT surveys are now justified as they provide vastly more data and allow more precise depth modelling of the conductivity anomalies we are targeting.

Another development is the detection of lithium by analysis of spectral data from drill core scans of the core from the Company's recent drilling (drill holes CBD-01 (Columbus Salt Marsh) and MBD-01 (Big Smoky South)). Selected sections of core are being prepared for assay to determine the amount of lithium present. This information will be used to assist in understanding the movement and deposition of lithium and brine compositions within the Company's projects.


