ICM does not itself own any securities of the issuer but exercises control or direction over certain securities of the issuer (as indicated in item 3.2 below) as the investment manager of the Fund.

The requirement to file this report was triggered on the 16th May 2018, when ICM, on behalf of the Fund, acquired 159,204 Chess Depository interests through an open market transaction on the ASX.
