Listing Rule 3.10.5A Disclosure and Appendix 3B

Pure Minerals Limited (**PM1 or the Company**) confirms that further to the ASX Announcement released 22 May 2018, in relation to the Placement, the Company has issued 43,750,000 fully paid ordinary shares at \$0.016 per share (**Placement Shares**).

The Company issued 40,594,359 Placement Shares under its placement capacity under Listing Rule 7.1, and 3,155,641 Placement Shares under its placement capacity under Listing Rule 7.1A.

The Company provides the following information as required under ASX Listing Rule 3.10.5A in respect of the shares issued under the Company's 10% Placement Capacity under Listing Rule 7.1A:
