

COMPLETION OF BECKER GOLD PROJECT ACQUISITION

4 June 2018 - Santana Minerals Limited ('Santana' or 'the Company') is pleased to announce that it has completed the acquisition of the Becker Gold Project ('Becker' or 'the Project') from Collerina Cobalt Limited ('Collerina' or 'CLL').


