

- Market rises 1.4% in May, with virtually all sectors showing gains. The telecommunication sub index was the only area to fall, with that index down 10.7% on the back of Telstra weakness.
- Several of our larger positions showed strong gains over the month, with our energy related exposures benefiting from a stronger oil price and Zenith Energy Limited releasing a project update. Our overall portfolio return (before allowance for fees and taxes) for the month was 6.1%.
- Cash levels continue to build, rising to 18% of assets at months end.
