## COMPLETION OF TD 009 – TURESI PROSPECT

### Highlights

- Drill Hole TD 009 was completed at 95m.
- From initial core logging 2 pegmatites were intersected. At 51.8m, 4.2m in thickness and at 70m, 0.75m in thickness (down hole depths and thicknesses).

Greenpower Energy Ltd (ASX: GPP) and the company's joint venture partner Guyana Strategic Minerals (GSM) confirm the completion of cored drill hole TD 009 at their Turesi Prospect in the Morabisi PGGs tenement in Guyana.

TD 009 was sited to test along - strike extensions of pegmatite intersected in TD 002

A description of the geology encountered in TD 009 is as follows (all measurements are down-hole depths and thicknesses):

- From the surface to 17.5m, brown saprolite
- From 17.5m to 35.5m, variably coloured saprolitic clays interpreted to be the result of in-situ weathering
- From 35.5m to the end of the drill hole at 95m, moderately foliated hornblende granite with thin (3cm to 20cm) pegmatitic quartz feldspar veining throughout.
- From 51.8m to 56.0m a 4.2m thick pegmatite was drilled
- From 70.0m to 70.75m a 0.75m thick pegmatite was drilled.

The drill rig has now been moved to pad TDH P14 to drill hole TD 010 at an azimuth of 014 degrees and a dip of 60 degrees which has been completed. The rig is now drilling TD-011 from a pad ~200 meters east of TDH P14.

All the drill core from drill holes TD 001 to TD 008 have now been cut at Turesi base camp and half core shipped to Georgetown for preparation of pulps for airfreighting to Perth, Western Australia for analysis.

Sample analysis is proceeding in Perth on pulps airfreighted from Georgetown.

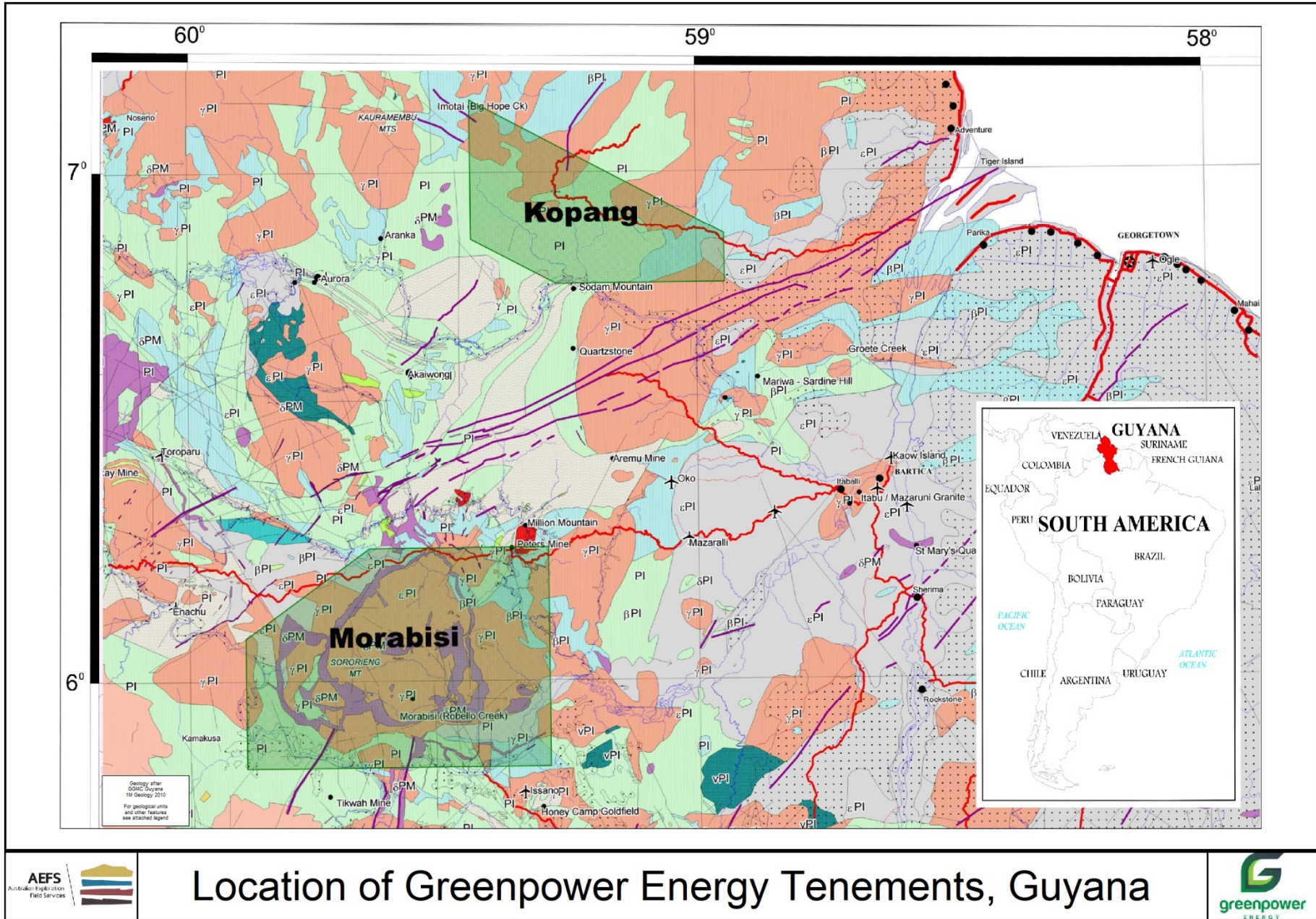

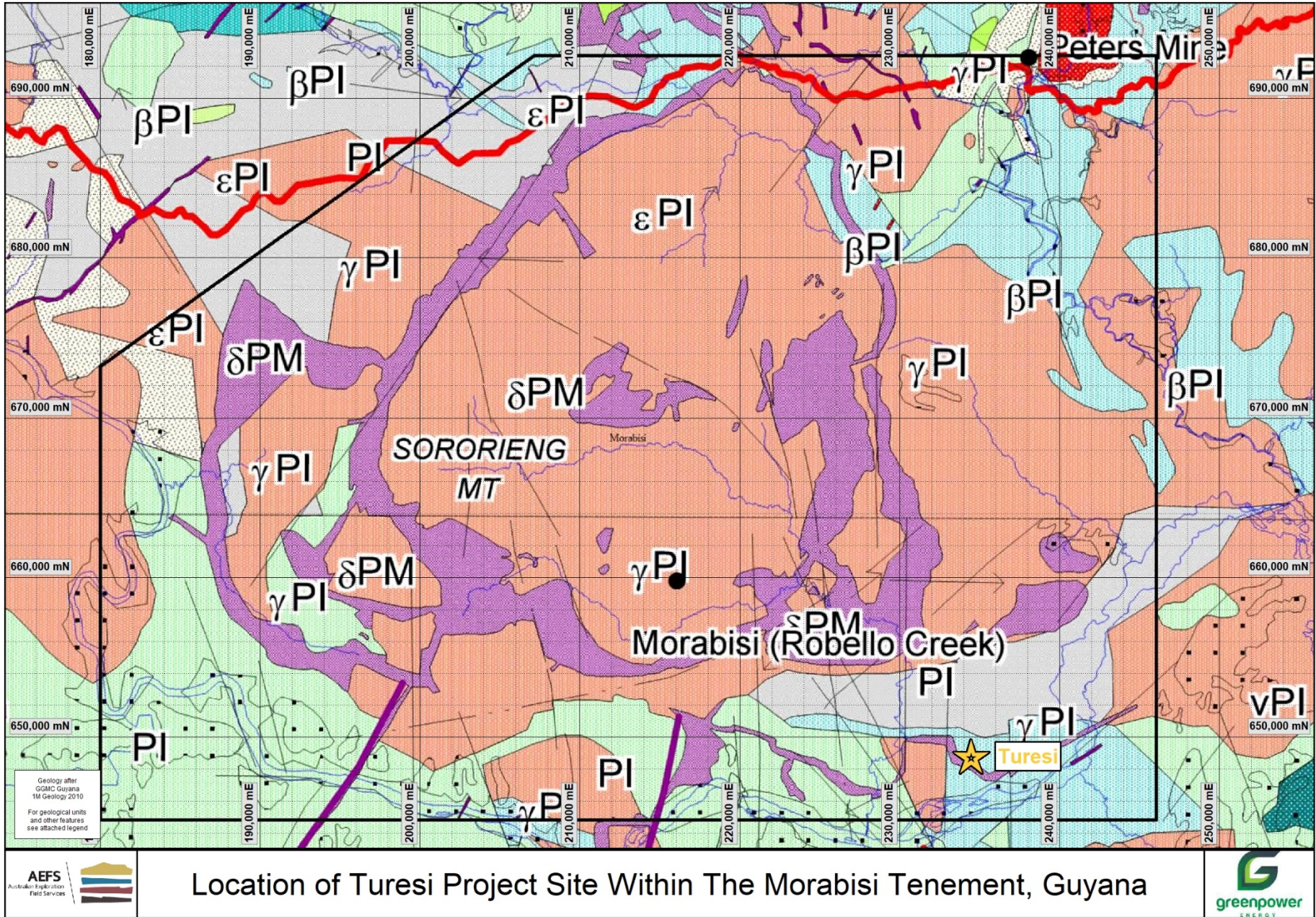

Location of Greenpower Energy Tenements, Guyana



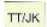
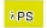

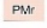
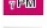









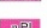







Greenpower's Morabisi Tenement

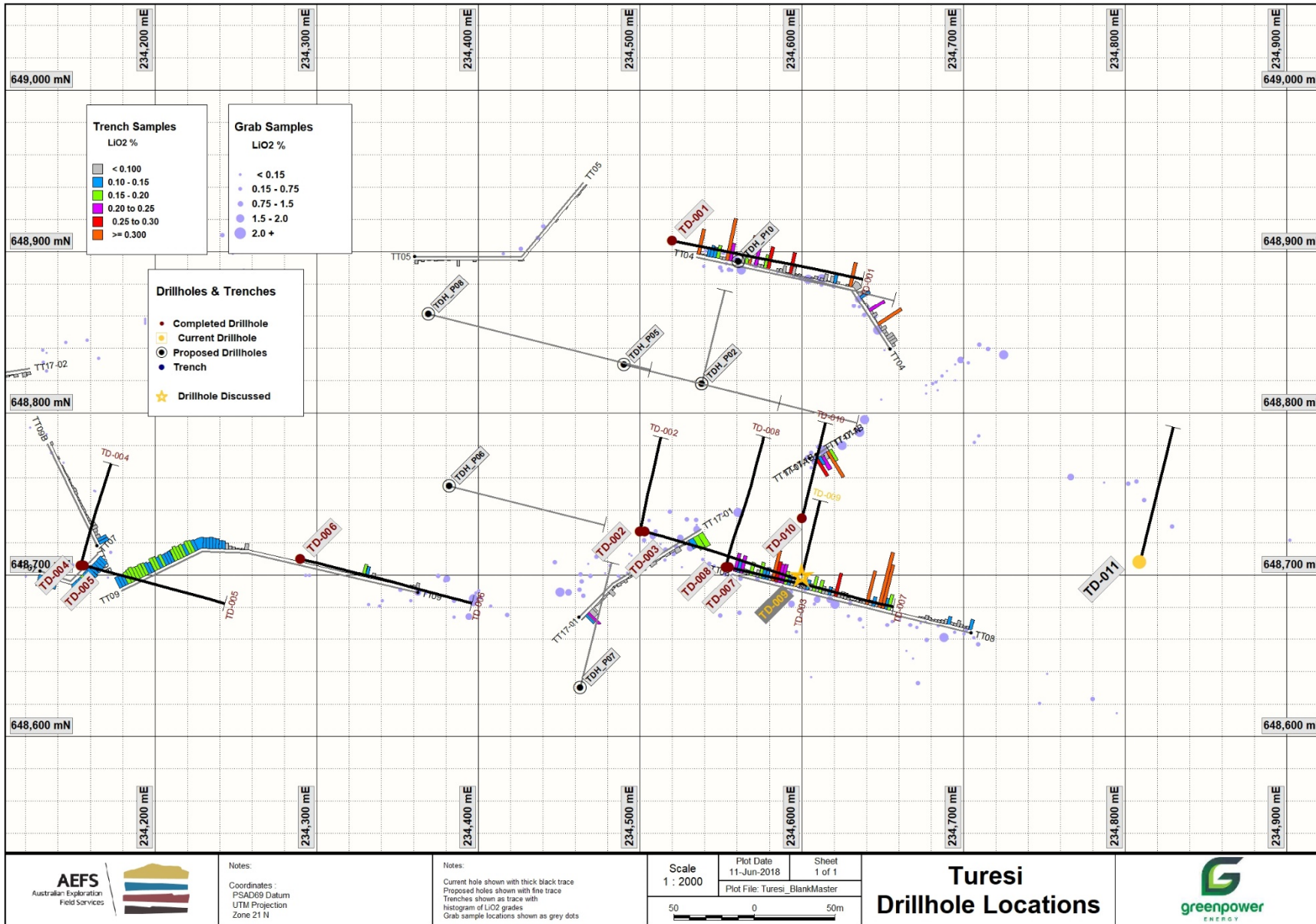


Location of Turesi Project Site Within The Morabisi Tenement, Guyana
