THERMAL CAMERA SYSTEM COMMERCIAL LAUNCH

HIGHLIGHTS

- First Thermal Camera orders received from multiple Tier 1 clients
- Commercial production of Thermal Cameras initiated

Australian-based remote security monitoring systems and cloud based technology solutions company ('Spectur' or 'the Company') (**ASX:SP3**) is pleased to announce the commercial launch of its new Thermal Camera systems.

FIRST SALES ORDERS RECEIVED

The Company has successfully commenced production of its new Thermal Camera systems receiving its initial orders from Tier 1 clients.

The first order is a two unit rental contract for an initial period of three months from a global motor company located in Victoria. The value of this contract for the initial three month period is \$9,000. As part of this contract, Spectur has been placed on the Tier 1 clients official (global) supplier list. The second order is a two unit sales contract to an international logistic company, based out of Victoria, totalling \$27,500.

COMMERCIAL MANUFACTURE INITIATED

The Company has scheduled the manufacture of five additional Thermal Camera systems per week to increase stock levels to meet anticipated rental and sales demand.

Spectur's Managing Director, Peter Holton, stated 'The commercial manufacture and first sales of the Thermal Camera systems to Tier 1 companies is highly encouraging and provides a platform for further growth. The Company's Thermal Camera system is a cutting-edge security product which can be used as an alternative to powered security systems, specifically to protect large perimeter fenced operations.'

ONGOING THERMAL CAMERA BUSINESS DEVELOPMENT OPPORTUNITIES

Significant interest is already being shown by Tier 1 companies who typically have extensive perimeter fences and assets to protect and who could benefit from thermal camera technology

Spectur is in a number of advanced pre-purchase activities with further potential Tier 1 clients across a range of industries. These activities include the process whereby Spectur is added to the official supplier list of the client, which can be a lengthy process for Tier 1 companies. Based upon its initial success and the reliability and versatility of its product, the Company is confident of being awarded supplier status for a number of new Tier 1 clients and anticipates that this will assist in securing additional thermal camera orders, being either sales or rentals.

SECURITY CONFERENCE

Spectur will be showcasing this new and exciting solar security product at the upcoming Australian Security Industry Association Limited Security Conference in Melbourne from 25-27 July, which is aimed at further accelerating demand and take-up of the thermal camera systems.
